Elizabeth In the Name of God Amen. I Elizabeth Blessing  
Blessings the County of Smyth and State of Virginia being in a low  
Will state of health, but of sound memory and disposing mind  
oh; and knowing that life is uncertain and that death is  
inevitable to all do hereby make this my last will and  
testament in manner and form following viz - after my  
just debts and funeral expenses are paid.

Item 1. I will and desire that my negro woman Betty be  
free at my decease, and must see to her own support during  
her life, as I shall not make any provision for her out of  
any part of my estate.

Item 2. I give and bequeath to my daughter Susan my  
board the one setting in my room, I also give to my daughter  
Ann Byars one small pot or oven which ever she may choose.  
Also I give and bequeath to my grand daughter Elizabeth  
daughter of my son Solomon my table also I give and  
bequeath to my grand daughter Elizabeth son of David Blessing one  
horse colt which is now in their possession. I also give and  
bequeath to my grand daughter Adaline Byars daughter of  
A B Byars one mare colt which they have in their possession.

Item 3. I give and bequeath to my grand daughter Debby  
son daughter of David Denton my riding saddle also I give  
bequeath to my grand daughter Elizabeth daughter of Jacob  
Blessing my small chest, I also give and bequeath to my  
daughter Eliza Smith one large oven, and one huckle, also I  
give and bequeath to my daughter Susan Byars one feather  
bed undressed, bedstead ~~tar~~ pillows, bolster, too sheets one blanket  
and one bed quilt or covered

Item 4. I give and bequeath the residues of all the property  
of every denomination or kind whatsoever belonging to me a  
all debts that may be due me to three of my daughters

Item 5. And lastly I do hereby appoint my son in law  
Arthur B Byars Executor to this my last will and  
testament with my last request be faithfully and  
with brotherly affection see and execute this my trust  
that I have reposed in him and also after a further  
consideration I give and bequeath to my grand daughter  
Elizabeth daughter of Jacob one heifer also I also  
give and bequeath to my son David Blessing four sheep  
he has in his possession of mine and lastly desire my  
Executor pay him the sum of Ten Dollars in money  
that may arise from the collection of any debts due my  
estate or otherwise. Given under my hand and seal this  
second day of May in the year of Our Lord eighteen  
hundred and thirty four.
